- Joint organization of seminars, conferences, workshops, FDPs, and training programs
- Collaboration in research, innovation, IPR, and publication activities
- Student participation in sports, cultural, extension, and outreach programs
- Activities aligned with IQAC, NSS, Skill Development, and Career Guidance Cell.
- Proper documentation including attendance, photographs, reports, and outcomes shall be maintained for AQAR and SSR submission.
- Enhanced **learning opportunities for students**.
- Exposure to **multidisciplinary and skill-oriented education**.
- Professional development of faculty members.
- Strengthening of **institutional quality indicators under NAAC**

This MoU does not automatically imply financial commitments. Any financial expenditure shall be decided **mutually in advance** and documented separately.


This MoU shall be valid for a period of **Five (05) years** from the date of signing and may be renewed based on mutual consent and performance review.

Either party may terminate this MoU by giving **three (03) months' prior written notice**. Activities already initiated shall be allowed to complete.
